
Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. Transportation to an average customer in Paris, France is 1,850 km (A4: average Euro 6 lorry > 32 tonnes). The use stage is not represented currently, as it varies very much, although the furniture as a rule require very little maintenance. End of life is represented by a dismantling and recycling of metals, whilst wood currently is being sent to incineration. We aim to change this as well.
