All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation:

The allocation is made in accordance with the provisions of EN 15804. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:


Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. The data quality of the raw materials in A1 is presented in the table below.

Specific data for the manufacturing processes (product stage A3) refers to the year 2020. All other specific data is from year of study.



System boundary:

The upholstering is manufactured at Kinnarps' production site in Skillingaryd, where the fabric is also processed. The steel and plastic components are purchased as premanufactured components. Final assembly of the product is done at Kinnarps' production site in Kinnarp.

LCA: Scenarios and additional technical information

The following information describe the scenarios in the different modules of the EPD.

The product is shipped to consumer in Kinnarps' trucks with blankets and cardboard sheets as packaging material which is returned to the factory after delivery and reused. This method saves 270 kg of packaging material per container and enables 50% more products to be transported in each truck. Kinnarps' trucks have a load efficiency of over 90% and are run on diesel with renewable content.
