Fenomastic Pure Colours Emulsion Semigloss IM(SA) is a superior quality emulsion paint, designed for interior surfaces. Based on special acrylic copolymer emulsion. The declared product offers good flow, hiding power, incan anti bacterial and colour retention properties. It provides smooth durable and washable semigloss finish.

Fenomastic Pure Colours Emulsion Semigloss IM(SA) is free from APEO and formaldehyde, and heavy metals have not been used as active ingredients. It has low VOC which ensures good indoor air quality and is ideal for decorating and protecting interior surfaces.

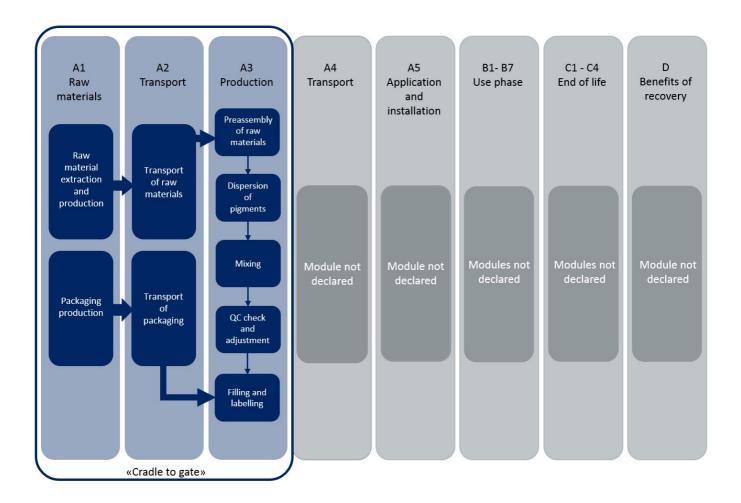
