The rubber fixture under the seat allows you to place the chair on the tip of your desk when you're done for the day. Similar to $Move^{TM}$, the $Move^{TM}$ Compact foam seat is available in a variety of upholstery options. The base is made from beech plywood covered with an ash top veneer. The surface is manually sanded and coated with a water-based lacquer available with a natural or black finish. The integrated rubber disk makes $Move^{TM}$ Compact suitable for use on all kinds of floor surfaces.

Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation:



The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. 
