The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. The recycling process and transportation of the material is allocated to this analysis.

Data quality:



Remarks to environmental impacts

The parameter GWP (A1-A3) includes 132 kg CO2-eq/tcement deriving from fossil and 132 kg CO2 eq/tcement from non-fossil components when combusting secondary (alternative) fuels for the production of cement clinker. In accordance with the "polluter pays" principle / EN 15804 /, the emissions will be added to the production system that caused the waste. However, in this EPD, the CO2 contribution from components of secondary (alternative) fuels has not been deducted.

This is to be able to compare calculated global warming from cement regardless of the status of the waste in different countries.
