

## Remarks to environmental impacts

The parameter GWP (A1-A3) includes 117 kgCO2-eq per tcement deriving from fossil and 116 kgCO2-eq per tcement from non-fossil components when combusting secondary (alternative) fuels for the production of cement clinker. In accordance with the "polluter pays" principle / EN 15804 /, the emissions will be added to the production system that caused the waste. However, in this EPD, the CO2 contribution from components of secondary (alternative) fuels has not been deducted.

This is to be able to compare calculated global warming from cement regardless of the status of the waste in different countries.
