

# **Product**

## **Product description:**

Foundation block permanent non-load-bearing system comprised of EPS shuttering elements. The shuttering elements comprises two one-layered, 70 mm thick expanded polystyrene (EPS) leaves. They are linked by EPS binders to ensure stability in the shuttering system. The distance between the EPS binders is 240 mm. The rail anchors provide a 400 mm concrete thickness. The design of the spacers makes them suited for the precise placement of the reinforcement bars in the concrete and ensures that the reinforcement is properly positioned. The system consists of the standard shuttering element. The declared value of thermal conductivity is 0.035 W/m2K. Weight: 1,31 kg, length 1200 mm, width: 540 mm.

The system is intended for use in combination with Thermomur og Ringmur elements.

## Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

# Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

#### Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.


