Product description:

Rullspackel Grov is a redymade light, rollable filler for wide filling in thick layers on plaster, concrete, lightweight concrete and slab material indoors. The filler is very easy to apply and spread over the surface with a roller. Rullspackel Grov has very good filling capacity. The filler is flexible and grey in colour.

The filler meets the requirements for CE marking according to EN 15824.

Reference service life, product

Fillers have a limited shelf life and are date-marked. Unopened packaging can be kept in a dark place, free from frost, for up to 12 months. Containers that have been opened must be resealed well.

Reference service life, building

The EPD does not cover the service life of the building.

Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.


