Product

Product description:

Reclaimed building bricks. The bricks are sourced from demolition projects in the region, and the demolition waste is transported to Utomhus Østfold Gress' facility, where reusable bricks are identified and prepared for reuse in new construction projects. Damaged bricks are used in other products, while the remainder is delivered for use as filler mass in sub-base layers or embankment materials for infrastructure projects in the region. The EPD is based on an assumed average distance from demolition sites in the region to Utomhus Østfold Gress' facility, thus representing an average product.

Product specification:

The product is reclaimed bricks without any additives.

Technical data:

The bricks have a standard dimension of $240 \times 115 \times 70$ mm and an average weight of 3 kg. They are stacked and marketed on wooden pallets. Utomhus Østfold Gress buys used pallets for transport. It is conservatively assumed that these pallets can be reused 5 times; hence 1/5 of the production impacts are included in the assessment.

According to TBE PCR for clay construction products, the RSL for bricks is 150 years. Depending on the source of the reclaimed bricks, their RSL can be expected to be shorter than this to a degree.



Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials allocated to the main product in which the material was used.

System boundary:

The system boundary is from cradle to grave (module A1-D). Modules A5 and B1-B7 are assumed to have negligible impacts according to the PCR guidelines. The flow chart for production, transport and end of life is shown in the figure below.



Cut-off criteria:

All major raw materials and all the essential energy is included. The production process for raw materials and energy flows that are included with very small amounts (<1%) are not included. This cut-off rule does not apply for hazardous materials and substances.
