

Perforated front panel should be attached with magnets for easy access to the coil, and the unit should be available pre-customized for various ceiling systems such as TA, DC, DG, DS, or EK.

Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.



2. This impact category deals mainly with the eventual impact of low dose ionizing radiation on human health of the nuclear fuel cycle. Potential ionizing radiation from the soil, from radon and from some construction materials is also not measured by this indicator.
